



# Memorandum of Understanding Between Chambal Foundation (CF), Etawah And Shia P.G. College, Lucknow

This memorandum of understanding is made on this 14 Day of May, 2019 between the Department of History and Department of Journalism and Mass Communication referred as DH and DJMC represented by Principal Dr. S.S. Rizvi and Chambal Foundation, Etawah represented by Mr. Shah Alam Rana.

#### Preamble:

Sharing a common desire to empower the thoughts of youth to understand indigenous notion of exploration of Historical evidences to identify the unsung heroes of freedom struggle and to document them by connecting past with present to build future in order to share the facilities and expertise available in each other's organisation herewith sign a Memorandum of Understanding (MOU) which read as follows:

#### Infrastructure:

Shia P.G. College will provide its Infrastructure for the Programs/Lectures/Seminars/Symposiums. This will include K-Hall auditorium, Reading room of Khateeb-E-Akbar Library. CF will facilitate in constructing the consensus of students enrolled in Lucknow Heritage Studies and in Journalism with the History of Revolutionaries.

#### Research Material:

CF will facilitate the Department of History and Department of Journalism and Mass Communication to create Chambal Archives and to offer a platform to meaningful debates, documentaries and award-winning films in different Indian languages. To encourage rural-journalism, and to advocate different issues of community, the organisation will Publish Newspapers, Magazines, Radio and TV Channel and to Organise Chambal "People's Parliament". The Department of History and Department of Journalism and Mass Communication will provide its studio, digital camera, computer, Printer, LCD, and Projector etc.

## **Curriculum Development:**

The experiments and workshops related with the topics from syllabus of Add- On Course/ Value added courses/ Generic elective courses for skill enhancement will be conducted. All of these courses will be approved by Board of Studies, the Department of History and Department of Journalism and Mass Communication, Academic Body of Shia P.G. College. CF will provide study material to facilitate the Department of History and Department of Journalism and Mass Communication in the development of curriculum and pedagogy development.

## Pedagogy:

- CF will be pleased to provide training to trainers, orientation and technical sessions, workshops offline/online for the benefit of students and teachers of Shia P.G. College, Lucknow.
- 2. CF along with the Department of History and Department of Journalism and Mass Communication work together in mutually agreed terms for carrying out training programs, lectures, seminars, conferences, workshops, fairs, counselling, services, and dissemination of any literature, awareness campaigns or any research activities.
- 3. The Department of History and Department of Journalism and Mass Communication will collaborate in Research Work/Projects/Dissertations to encourage rural-journalism, and advocate community on different issues.

#### **Steering Committee:**

There will be a steering Committee comprising of five members, two from Shia P.G. College and Heads of the Department of History and Department of Journalism and Mass Communication and one from CF. The Committee will look after all the proposals and other related issues.

### Timeline of MOU:

The above MOU will be effective for three years from the date of signing. The MOU will be periodically reviewed in a joint meeting to assess the progress and development of the present programs and also to identify new areas for collaboration.

The MOU reflects the commitments of respective organisations to terms and conditions mentioned in the MOU. This MOU shall be amended or terminated at any other time by either party provided that notice of termination or amendment is provided by the notifying party to the other party within thirty (30) days of the date on which the termination or the amendment is intended to be effective. Any amendment or termination shall not have effect on any arrangement in place at the time that the notice is to be served, where the arrangement arises from any Supplementary Agreements resulting from this MOU. Upon termination the provisions of this MOU and corresponding program, agreements shall continue to apply to ongoing activities until each is completed.

If any T.A.-D.A. of visiting faculty is required, it will be paid from the resources available in Department of History and Department of Journalism and Mass Communication from Self Financing Programs and Departmental Grant with prior approval of Principal, Shia P.G. College Lucknow. All supporting staff will be provided by Department of History and Department of Journalism and Mass Communication. Both parties agree to the above in Principle subject to such other formalities required by the respective Governing bodies including the competent authority.
