



Memorandum of Understanding between School of Management Sciences, Lucknow (First Party)

and

Shia P.G. College, Lucknow (Second Party)

This Memorandum of Understanding is made on Friday, Twenty Second of October Year Two Thousand and Twenty One (22/10/2021) between School of Management Sciences, Lucknow represented by Prof. (Dr.) Manoj Mehrotra, Principal and Shia P.G. College, Lucknow by Dr.Mohd. Miyan, Principal (Officiating).

Preamble: Sharing a common desire to empower the thoughts of youth to understand indigenous notion of exploration of advancements of knowledge in the field of science, commerce and computer studies to build future of the students especially who want to do research and practical projects. In order to share the facilities and expertise available in each other's organisation herewith sign a Memorandum of Understanding (MOU) which read as follows:

Infrastructure: School of Management Sciences, Lucknow will facilitate in constructing the consensus of students enrolled in the add-on courses of the Renewable Energy, Machine Learning, Artificial Intelligence, IOT and Big Data, Thermal Energy etc.by providing its infrastructure like; Lecture Theatres, Labs and Library etc. for the same.

Shia P.G. College, Lucknow will provide its Infrastructure for the Programs/Lectures/Seminars/Symposiums. This will include K-Hall auditorium, Laboratory, Reading room of Khateeb-e-Akbar Library.

Research Material:In order toescalate scientific temperament among theStudents, both the parties will facilitate the students to create and offer a platform to meaningful researches, debates, research papers, articles etc. along with publications of journals, books etc.in different languages as per theNew Education Policy (NEP).

Curriculum Development: The experiments and workshops related to the topics from the syllabus of Add- on courses/ Value added courses/ Generic elective courses for Skill Enhancement will be conducted. All of these courses will be approved by the Board of Studies/ Academic council of the School of Management Sciences, Lucknow. Shia P.G. College Lucknow will provide study material to facilitate the conduct of various programs like ADD ON/ VALUE ADDED courses for the development of curriculum.

Pedagogy:

- Shia P.G. College, Lucknow will be pleased to provide training to trainers, orientation and technical sessions, workshops offline/online for the benefit of students and teachers ofSciences Faculty, School of Management Sciences, Lucknow.
- 2. School of Management Sciences, Lucknow along with the Shia P.G. College, Lucknow work together in mutually agreed terms for carrying out training programs, lectures, seminars, conferences, workshops, technical fairs, counselling, services, and dissemination of any literature, awareness campaigns or any research activities.
- School of Management Sciences, Lucknow will collaborate in Research Work/Projects/Dissertations to encourage easy access o technology, and advocate science community on different issues.

Steering Committee:

There will be a Steering Committee comprising of four members, twofromSchool of Management Sciences, Lucknow and two from Shia P.G. College, Lucknow. The Committee will look after all the proposals and other related issues.

Timeline of MOU:

- i) The above MOU will be effective for Three Years from the date of signing.
- ii) The MOU will be periodically reviewed in a joint meeting to assess the progress and development of the present programs and also to identify new areas for collaboration.
- iii) The MOU reflects the commitments of respective organisations to terms and conditions mentioned in the MOU.
- iv) This MOU shall be amended or terminated at any other time by either party provided that notice of termination or amendment is given by the notifying party to the other party within thirty (30) days of the date on which the termination or the amendment is intended to be effective.

- v) Any amendment or termination shall not have effect on any arrangement in place at the time that the notice is to be served, where the arrangement arises from any supplementary agreements resulting from this MOU.
- vi) Upon termination the provisions of this MOU and corresponding program, agreements shall continue to apply to on-going activities until each is completed.

Travelling Expenses:

If any T.A.-D.A. of visiting faculty is required, it will be paid from the resources available in head from Self Financing Programs and Departmental Grant with prior approval of Principal, Shia P.G. College, and Lucknow. All supporting staff will be provided on mutually agreed strength by School of Management Sciences, Lucknow, and Shia P.G. College, Lucknow. Both parties agree to the above in principle subject to such other formalities required by the respective governing bodies including the approval of competent authority.
