Memorandum of Understanding (MOU)

Between

"Association for Advocacy and Legal Initiatives Trust" (AALI)

And

Faculty of Law, Shia P.G. College, Lucknow

The present memorandum of understanding is made on D3. Dec.-2021 between Faculty of Law, Shia P.G. College, Lucknow and "Association for Advocacy and Legal Initiatives" referred as AALI by our esteemed Principal (Officiating), Dr. Mohd Miyan and AALI Trust, Lucknow.

Preamble: The prime aim of the above mentioned MOU is to transform the ideas, efforts, Legal complexities and implementation of Laws relating to the protection and promotion of Human Rights of women especially in India through the Legal provision, to establish a common paradigms of legal remedies to the victims of violation and atrocities, not merely within the four walls of home but also at work place.

college will provided: Shia P.G. College will make available it's Infrastructure for conducting the Lectures, Seminars, Workshop and Symposium both offline as well as online mode. The college will provide it's departmental Law Library, Imam Ali (a.s.) Moot Court Hall, Khateeb-E-Akbar Central Library along with Reading room and K-Hall Auditorium to AALI during the course of Workshop.

Material for Research: Faculty of Law, Shia P.G. College, will provide All India Reporters (AIR), Supreme Court Cases (SCC), Criminal Law Journals (CrLJ), Textbooks, E-Books and Reference Books, on the subject on which the workshop is being organised. Both the organisations will encourage the Legal professionalism and tactics of Advocacy on different contemporary issues. The college will also provide studio, computer along with printer and camera, etc.

Control of the Contro

Curriculum: The development of Curriculum for the various contemporary issues and problems will be made by the College and AALI jointly. The Add on Courses are running on the various socio-legal issues and problems regarding Women and Girls. The syllabi for the said Add on Courses are to be prepared by the Faculty of Law, Shia P.G. College, and approved by the Board of Studies of the Faculty.

Guidance:

- I. AALI will shoulder the responsibility to provide orientation programmes, conducting seminars, technical sessions, workshops for the enlightment of the students and teaching faculties of the Shia P.G. College in offline and online mode as well.
- II. AALI along with the Faculty of Law mutually agreed on the specific terms and conditions to organise guest Lectures, seminars, conferences, workshop, Moot Court Programmes, Counselling services, Free Legal Aid and Legal Awareness Programmes.
- III. The Faculty of Law also collaborate in research activities, projects, dissertation and research papers.

Steering Committee: The said committee will consist of five members, two from Shia P.G. College and Head of the Department of Law, two from AALI. The steering Committee will supervise all the related issues and proposals.

Timeline of MOU:

I. The present MOU will be effective and enforced from the date of its signing for one year. It will be reviewed after one year and reviewed if required. Through the joint

meeting there will be the assessment, progress and development of the various programs made during the session and there will also be the search and identification of nascent areas of such collaboration.

- II. The present MOU will be in accordance that at least one session will be organised by Shia P.G. College quarterly and AALI will be faciliate that session.
- III. The present MOU shows the commitments and obligations of respective organisations that is AALI and Faculty of Law, Shia P.G. College, Lucknow to the terms and conditions enshrined in the MOU. The MOU can be amended, modified or terminated at any other time by either party. It is provided that the adequate notice should be given to the other party within fifteen (15) days of the date on which the amendment, modification or termination is intended to be made. Upon the termination of the provisions of the MOU, the corresponding programmes and agreements shall be continued until each programme is completed in the fullest term.

At the occasion where T.A./D.A. is required to the resource persons or visiting Faculties, the Faculty of Law, will organise the same after getting the approval of Principal of Shia PG College Lucknow. All the teaching and non teaching staff of the Faculty of Law, will support any activities done by the Joint venture of AALI and Faculty of Law, Shia P.G. College, Lucknow. Both the parties agree to the above mentioned norms and standards subject to such other formalities as required by the governing bodies which include the approval of the competent authority.
